### Introduction.

We are at a pivotal moment in human history. The way we deploy distributed ledger systems offers the possibility to ensure the well-being of all and a "safe operational space for humanity", a feature that we have failed to accomplish in the past 40 years.

At the same time, Europe is called upon to change profoundly in the age of 21st century totalitarianism and the need to create a new relationship with the citizens of all of Europe as well as with the Global South. Faced with the challenges for our security and our resilience, and the urgent need to accelerate the implementation of the Sustainable Development Goals, it is imperative to "change the rules of the game".

This opportunity arises thanks to "digital decentralized empowerment tool" for fighting corruption, tackling organised crime, restoring confidence, considerably increasing our efficiency, measuring our impact and protect our values, reorienting the management of our economy and finance, a "Game Changer" to "Regenerate the Planet and Regenerate Europe" leading to new development models, an economy of transparency, just transition and values redistribution.

The BC100+ initiative of The-EPE has convened a *Steering Group* bringing together technology, sustainable development and science for global strategic leadership of the use of blockchain applications to achievement of the SDGs.


